SUBJECT: MEETING MINUTES – 17 FEBRUARY 2000

1. The monthly Chiefs' Group meeting was called to order by the President at 11:45, 17 February, 2000.
2. **ATTENDANCE:** 35 members.
3. **OLD BUSINESS:**
 - The January minutes were read by chief Beary and approved
 - New officers were announced:
 - President:** Chief Bob Langston
 - Vice President:** Chief Will Beary
 - Secretary:** Chief Mike Thomas
 - Treasurer:** Chief Mike Leies
 - Chiefs' Induction Ceremony financial outcome was given:
After all expenses, the Chiefs' Group had a **Net Profit of \$ 97.50**
 - **Treasurer's Report** was given:

Savings Account Balance:	\$ 387.05
Checking Account Balance:	\$ 962.72
Total Balance:	\$1,349.77
 - Annual Dues were taken up (**\$ 24.00**)
4. **NEW BUSINESS:**
 - Discussed **Funding of Savings Bond for 1st Sgt Wing Annual Award Winner:** It was moved, seconded, and passed that a **\$50 Savings Bond** be given for both **Active & Reserve winners & it be retroactive for the 1999 winners.**
 - Discussed **Authorization to increase Exec. Committee spending from \$30 to \$50:** It was moved, seconded, and passed that this authorization **not be** increased to \$50, but **increased to a limited of \$100.**
 - Discussed **Proposal to have 1 or 2 Golf Tourneys as fund raisers as well as decreasing the number of Fish Fries to 1:** Sponsors would be asked for donations to purchase prizes for the Golf Tourney, thus giving the Chiefs' Group more net profit. It was moved, seconded, and passed that the Chiefs' Group would **have at least 1 Golf Tourney (Spring time frame) and 1 Fish Fry (Fall time frame).**
 - Discussed **Proposal to change the type of Chiefs' bust we give for retirements:** It was moved, seconded, and passed that a **new Chief bust** be used **until Chief Copeland could bring in another Chief bust to compare** at which time a final

decision could be made. It was also decided to keep one of each bust the Chiefs' Group has given and place them in the Chiefs' display in the Club.

- Chief Childers brought up a request by **Bank of America** to come **twice a year** (maybe once a quarter) to talk to the Chiefs' Group. They would of course pay for lunch! Their first visit would be during the month of **April**. This was moved, seconded, and passed.
- Chief Langston brought up **next year's Chiefs' Induction Ceremony** and trying to get sponsors rather than the Chiefs' Group donating \$600 to \$900 up front. This was well received and **agreed upon**.

- Chief Thomas is looking into producing a Calendar of Events
- Chief Thomas is looking into setting up a Web Page for the our chiefs' Group
